## COURSE DESCRIPTIONS

### 9 Minutes

When an everyday EMS call for an ill person turns into a residential house fire with a victim trapped, the only people on scene are the EMS crew in their ambulance, turn-out gear, and 2 SCBA's. September 5th, 2018, is a day that changed the Springfield Twp. Fire Department and myself forever. With no discretionary time, and a life hanging in the balance this class will walk the students through the entirety of the call. The audio tapes from this run give an intimate view on how the events unfolded that day. Along with the fire ground audio the audio tapes from the 911 call takers and dispatch give the students and opportunity to see what happens on the backside of calls before crews are even dispatched.

- Strategies and Tactics utilized by crew to search for the trapped victim
- Fire Ground Command and Control decisions utilized by the Lieutenant on scene (Me)
- Search and Rescue
- Lessons learned from the near miss event
- Mental health considerations, taking care of our firefighters after a critical call like this and ensuring we take care of them after the call, no matter what it takes.

**Clean Work: Firefighter Carcinogen Exposure Reduction**

Clean Work is an educational program designed for firefighters to improve the understanding and prevention of firefighter duty related cancer. The presentation will support how a hazmat approach should be applied to fire suppression activities, the opportunity for carcinogen exposure reduction during fire attack, post fire atmospheric monitoring, and firefighter personal protective equipment (PPE) decontamination process. Clean Work will provide the essential facts on hydrocarbon and fluorinated surfactants to include Class A concentrates, fluorinated Class B firefighting foam, and the new "green" Class B (non-fluorinated/F3) foam agents. This enriching session will include classroom, live demonstration and hands-on skills to reinforce the objectives on how you can make your firefighting work environment "cleaner" for your safety. ### **Decision Making for Leaders**

Effective leaders make decisions—it comes with the territory. But our research has shown that most decisions that leaders make do not result in immediate and effective implementation. It's not that leaders don't make high quality decisions but more often, they do not think through the requirements for buy-in and ownership by those who will be charged with implementation. And everyone is aware of poor decision-making practices. Starting with an overview of the use of authority in leadership, this session is intended to help participants gauge their own preference in authority usage. Secondly, participants should come to understand that in a leadership position, matching authority style to situational demands can reduce the potential for conflict, enhance decision acceptance and hence improve implementation. Using a series of case studies and a model for decision-making, participants will learn the value of using a range of decision styles. Rather than suggest that there is a “universal best style,” this session will help participants understand that optimal decision making for implementation involved “the best style given the group (team, organization) involved and the situation at hand. Having demonstrated a rational “decision tree” approach to improving effectiveness, we will also present evidence that there is more to leadership than purely rational thought.

**Development and Application of a Standard Operating Guideline for Below Grade/Basement Fires in Residential Occupancies**

Below-grade/basement residential fires present inherent dangers during firefighting operations. Numerous line-of-duty deaths and near misses have occurred in the last two decades. Colerain Fire and EMS experienced both a near miss in 2003 and a double line-of-duty death in 2008 at below-grade/basement residential fires. Following the tragic double line-of-duty death in 2008, a comprehensive internal investigation made several recommendations, including development of a Standard Operating Guideline (SOG) for below-grade/basement fires. Henceforth, the Below-Grade/Basement Fire Standard Operating Guideline has been successfully applied on numerous occasions with none more so than at a residential structure fire in November 2016. This structure fire presented itself with challenges and hidden dangers that had we not learned from the past it is possible that another history-repeating event with equally tragic consequences may have occurred. However, the successful application of the Below-Grade/Basement Fire SOG and the use of a transitional attack resulted in a successful fireground operation. Unequivocally speaking then, the development and use of a SOG for Below-Grade/Basement Fires is paramount to safe and effective fireground operations.

**Fire Station Location Analysis: Pre-Planning for the Future of Your Department - Tools for Location Analysis**

Two of the most difficult things to do with a fire station are to build one in a neighborhood and the other is to take one out of a neighborhood. As experts in fire station design our team is all too familiar with the challenges municipalities and departments face when considering the location of a new or relocated station. This process is incredibly complex, with direct effects on the safety of a community. Our team has developed a data-driven approach to provide a more informed decision to help improve overall coverage and effectiveness of departments, large and small, across the US.

The time that it takes for an emergency response team to arrive at an emergency situation is critical to the safety of a community. By utilizing GIS data, historic dispatch and traffic data, and relevant demographic data, a municipality can recognize the areas of deficiencies in coverage and opportunities to improve the overall effectiveness of their emergency response teams, lowering the risks to their community.

### **Today's Training Officer: Techniques for Modern Times**

What does it mean to be a training officer in today's fire service? Take a second to think about that. Sure, it means that we have to be credible in the subject we are teaching, but what else is there beyond just "knowing the subject"? Our job as training officers entails so much more than just understanding the knowledge, skill or ability we are attempting to impart on those in attendance. If we truly seek to be effective educators, we must first understand our audience.

We are not in the business of only hiring robots (at least not yet). We are still hiring humans. Humans with personal and professional interests, needs and feelings. The environment we work in as well as the resources we may have at our disposal are also different. Technology, for example, continues to change by the second.

I have served as the Training Coordinator for our department since 2011. Perhaps my biggest takeaway during this time is how many layers exist regarding even on simple skill such as pulling a crosslay. Simply pulling the crosslay off the truck does not make one proficient in its use. To be proficient, you would need to know the answer to three critical questions: 1. Why, 2. When, and 3. How.

The more serious or complex an incident, the more resources are called in to assist local and regional crews already working hard on the front lines. An AHIMT is a SLTT or OFA incident command organization that provides logistical, planning, financial, and operations support to manage an incident or event.
